## **ASSUMPTION OF RISKS:**

I acknowledge the known and unanticipated risks that can result in physical injuries to myself and others, emotional injury, death, and damage to personal, public, third party, and Megazone's property. By participating in the Activities provided by Megazone, I freely and fully assume and agree to the hazards and risks, and to use my best judgment while engaging in those activities.

## WAIVER OF CLAIMS AND INDEMNIFY AND RELEASE OF LIABILITY AGREEMENT:
